THE SPECIAL ECONOMIC ZONES ACT

THE SPECIAL ECONOMIC ZONE (SUTHERLAND GLOBAL SERVICES JAMAICA PLC LIMITED—
PART OF NEW KINGSTON FORMERLY PART OF KNUTSFORD, NOW KNOWN AS NUMBERS
THIRTY, THIRTY-TWO, THIRTY-FOUR AND THIRTY-SIX KNUTSFORD BOULEVARD IN THE
PARISH OF SAINT ANDREW) Order, 2019

In exercise of the powers conferred upon the Minister by section 18(1) (Designation of Special Economic Zone), section 22 (Minister's approval required), section 27 (Duration of master-concession and licence agreement) and section 53 (Tax incentives applicable to former Free Zones) of the Special Economic Zones Act, 2016, the following Order is hereby made:—

1. This Order may be cited as the Special Economic Zone (Sutherland Global Services Jamaica PLC Limited—Part of New Kingston formerly part of Knutsford, now known as NUMBERS THIRTY, THIRTY-TWO, THIRTY-FOUR AND THIRTY-SIX Knutsford Boulevard in the parish of Saint Andrew) Order, 2019.

2. The Strata lot 1–10, Numbers 30–36 Knutsford Boulevard, St. Andrew referred to in the Certificate of Title registered at Volume 1140 Folios 917-926

Property comprises the entire ten floors of the ten storey building located on Lots 287–290 of Deposited Plan No. 2072 and now known as 30–3 Knutsford Boulevard in the parish of St. Andrew and registered as Strata Plan 144 at Volume 1140 Folios 917–926, comprising in total 6,68.4 square metres and commencing at the northern corner, thence south-easterly for a distance of 19.8 metres to another corner, thence south-westerly for a distance of 0.4 metre to another corner, thence south-easterly for a distance of 2.6 metres to another corner, thence south-westerly for a distance of 2.5 metres to another corner, thence south-easterly for a distance of 5.5 metres to another corner, thence south-westerly for a distance of 2.7 metres to another corner, thence south-easterly for a distance of 0.4 metre to another corner, thence south-westerly for a distance of 31.8 metres to another corner, thence north-westerly for a distance of 28.5 metres to another corner, thence north-easterly for a distance of 37.8 metres to the starting point.

3. The Special Economic Zone to be a Single Entity Developer and may be referred to Sutherland Global Services Jamaica PLC Limited.

4. The Special Economic Zone Authority to enter into a Licence Agreement with Sutherland Global Services Jamaica PLC Limited.
