THE SPECIAL ECONOMIC ZONES ACT

THE SPECIAL ECONOMIC ZONE (SYNCHROSOURCE OFFSHORE SOLUTIONS LIMITED—PART OF BOGUE ESTATE IN THE PARISH OF SAINT JAMES BEING THE LOT NUMBERED B11) ORDER, 2019

In exercise of the powers conferred upon the Minister by section 18(1) (Designation of Special Economic Zone), section 22 (Minister's approval required), section 27 (Duration of master-concession and licence agreement) and section 53 (Tax incentives applicable to former Free Zones) of the Special Economic Zones Act, 2016, the following Order is hereby made:—

- 1. This Order may be cited as the Special Economic Zone (Synchrosource Offshore Solutions Limited —Part of Bogue Estate in the parish of Saint James being the lot numbered B11) Order, 2019.
- 2. All that parcel of land being Lot number B11 registered at Volume 1377 Folio 486 and being part of Bogue Estate in the parish of Saint James.

Commencing at the north-western corner of Lot B11 which intersects with Lot B10 and reserved road number one, travelling for thirty two meters and one hundred and twenty six thousandths of a meter (30.126m) in a south-easterly direction to meet at the intersection with Lot B11, Lot B12 and Reserved Road number one.

Then continuing south-westerly for fifty-six and five hundred and thirty thousandths of a meter (56.530m) to the intersection of Lot B11, Lot B12 and the property registered at Volume 1310 Folio 534 in the name of The Commissioner of Lands and currently occupied by The National Water Commission.

Then continuing north-westerly for thirty one meters and three hundred and eighty six thousandths of a meter (31.386m) until reaching the intersection with Lot B11, Lot B10 and the property registered at Volume 1310 Folio 534 in the name of The Commissioner of Lands and currently occupied by The National Water Commission.

Then continuing north-easterly for fifty-six meters and two hundred and ten thousandths of a meter (56.210m) until reaching the starting point where it intersects with Lot B10 and reserved road number one.

Unit 8 has an area of 78.1 square metres and is located on the second floor of the building on Lot B11 described above. Unit 9 has an area of 130.9 square metres and is located on the second floor of the building on Lot B11 described above.

- 3. The Special Economic Zone to be a single entity developer and may be referred to as Synchrosource Offshore Solutions Limited.
- 4. The Special Economic Zone Authority to enter into a Licence Agreement with Synchrosource Offshore Solutions Limited.
