THE SPECIAL ECONOMIC ZONES ACT

**THE SPECIAL ECONOMIC ZONE (WEST INDIES PETROLEUM SOUTH TERMINAL LIMITED—
PART OF LONG'S WHARF) ORDER, 2019**

In exercise of the powers conferred upon the Minister by section 17 (Restriction on Single-Entity Zones), section 18(1) (Designation of Special Economic Zone) and section 22 (Minister's approval required) of the Special Economic Zones Act, 2016, the following Order is hereby made:—

1. This Order may be cited as the Special Economic Zone (West Indies Petroleum South Terminal Limited—Part of Long's Wharf) Order, 2019.

2. Beginning at the south-east corner of Volume 1471 Folio 801 common to Volume 537 Folio 24 and the Caribbean Sea thence south twenty nine degrees ten minutes west a distance of sixty two metres and five hundred seventy seven thousandths metre; thence south thirty eight degrees thirty eight minutes west a distance of forty two metres and six hundred ninety nine thousandths metre; thence south fifty seven degrees fifty three minutes

west a distance of twenty seven metres and five hundred eighty eight thousandths metre; thence south seventy seven degrees twenty six minutes west a distance of thirty metres and one hundred thirty two thousandths metre; thence south fifty eight degrees fourteen minutes west a distance of fifteen metres and thirty seven hundredths metre; thence south fifty eight degrees fourteen minutes west a distance of thirty one metres and eight hundred thirty five thousandths metre; thence south seventy seven degrees forty nine minutes west a direction of five metres and four hundred twenty seven thousandths metre; thence south sixty six degrees thirty four minutes west a distance of one hundred fifteen metres and seven hundred two thousandths metre; thence south seventy four degrees thirty minutes west a distance of thirteen metres and twenty nine hundredths metre; Butting on Volume 485 Folio 82 thence north twenty nine degrees eight minutes west a distance of ten metres and six hundred forty seven thousandths metre; thence north twenty seven degrees twenty one minutes west a distance of nineteen metres and seven hundred eighteen thousandths metre butting on Volume 537 Folio 24 thence north twenty seven degrees twenty one minutes west a distance of forty one metres and seven hundred ninety six thousandths metre; thence north five degrees twenty two minutes east a direction of forty metres and one hundred fourteen thousandths metre; thence north thirty four degrees fifty six minutes west a distance of twenty six metres and two hundred eighty four thousandths metre; thence north thirty two degrees fifty five minutes west a distance of one hundred forty one metres and four hundred eighty three thousandths metre; thence north thirty nine degrees twenty three minutes east a distance of sixteen metres and three hundred and twenty six thousandths metre butting on a Reserves Road leading to the Old Harbour to Free Town Main Road thence north fifty one degrees thirty six minutes east a distance of fifteen metres and three hundred ninety nine thousandths metres butting on Volume 537 Folio 24; thence north fifty nine degrees thirteen minutes east a distance of one hundred sixty six metres and one hundred seventy eight thousandths metre; thence south fifty one degrees forty three minutes east a distance of one hundred seventy metres and fifty hundredths metre; thence south forty four degrees seventeen minutes east a distance of four metres and three hundred ninety eight thousandths metre; thence south forty four degrees seventeen minutes east a distance of one hundred two metres and six hundred twenty one thousandths metre; which is the point of beginning, containing by survey eight point two two hectares or howsoever it may be butted, bounded or described.

3. The Special Economic Zone to be a Single Entity Zone referred to as West Indies Petroleum South Terminal Limited.

4. The Special Economic Zone Authority to enter into a Licence Agreement with West Indies Petroleum South Terminal Limited.
