The following supersedes the publication appearing in the Jamaica Gazette Proclamations, Rules and Regulations on September 21, 2018:

THE SPECIAL ECONOMIC ZONE ACT

THE SPECIAL ECONOMIC ZONE (WESTERN TERMINALS LIMITED) ORDER, 2018

In exercise of the powers conferred upon the Minister by section 18(1) (Designation of Special Economic Zone) and section 22 (Minister's approval required) of the Special Economic Zone Act, 2016, the following Order is hereby made:—

1. This Order may be cited as the Special Economic Zone (Western Terminals Limited) Order, 2018.
2. Commencing at the most north-westerly point of the boundary of the lands hereinafter described, the said point is that which intersects the Kingston Wharves Public Bonded Area and the existing reserved road off Marcus Garvey Drive that serves Tinson Pen Aerodrome

at a distance of ninety-four (94) meters travelling in a south easterly direction, thence generally south-westerly at twelve (12) meters being a chain link fence, intersects another point on the chain link fence which thereafter, travels in a greater south-easterly direction at a distance of two hundred and thirty-eight (238) meters bounded by the Aerodrome asphalted parking area, which enters upon land registered at Vol. 1147 Fol. 213, to intersect another point on a chain link fence travelling in a north-easterly direction at thirty-five (35) meters, then bounding another point in a south-easterly direction at forty-one (41) meters, then in a general north-easterly direction to a point twenty-three (23) meters, then a south-easterly line at a distance of seventy (70) meters to a wire fence, then at a distance of one hundred and ten (110) meters in a south-westerly direction along a chain link fence to adjoin Marcus Garvey Drive. The boundary runs on a north-westerly direction at an offset distance of twenty-one (21) meters from the road centreline of Marcus Garvey Drive to a chain link fence post southwest of the point of beginning at a distance of twenty-one (21) meters and twenty-three (23) meters. All this said land inclusive of all easements for drainage and pipelines, roadways, pathways, blocks of lots and parcels containing Kingston Wharves, as shown on Plan Attached, encompassing thirty two thousand, nine hundred and fifty square (32950) meters or eight (8) acres of land, part of Tinson Pen in the parish of St. Andrew.

3. The Special Economic Zone to be referred to as Kingston Wharves Special Economic Zone.

4. The Special Economic Zone Authority to enter into a Licence Agreement not to exceed August 31, 2022 with Western Terminals Limited.
