THE SPECIAL ECONOMIC ZONES ACT

THE SPECIAL ECONOMIC ZONE (WHEELERSFIELD DEVELOPMENT LIMITED — PART OF UP PARK CAMP AND PART OF LOWER SWALLOWFIELD, St. ANDREW) ORDER, 2019

In exercise of the powers conferred upon the Minister by section 18(1) (Designation of Special Economic Zone) and section 22 (Minister's approval required) of the Special Economic Zones Act, 2016, the following Order is hereby made:—

- 1. This Order may be cited as the Special Economic Zone (Wheelersfield Development Limited Part of Up Park Camp and Part of Lower Swallowfield, Saint Andrew) Order, 2019.
- 2. Part of Up Park Camp known as Number 2 South Avenue located in the parish of Saint Andrew registered at Volume 1266 Folio 17, commencing at the southern corner of the property at the intersection between Curphey Place and Arthur Wint Drive measuring westerly along Curphey Place for a distance of eighty-five metres and six hundredths of a metre, thence in a northerly direction bounded by Number 4 South Avenue to the west for a distance of seventy-two metres and twenty-nine hundredths of metre, bounded to the north by South Avenue,

thence easterly along said South Avenue measuring sixty-one metres and eighty-one hundredths of a metre, continuing easterly measuring sixty-two metres and ten hundredths of a metre bounded to the north by Number 1 South Avenue, thence southerly along Arthur Wint Drive measuring one hundred and forty-three metres and ten hundredths of a metre to the starting point.

- 3. Part of Lower Swallowfield known as Number 1 South Avenue located in the parish of Saint Andrew registered at Volume 1218 Folic 761 and Volume 1311 Folio 895, commencing at the northern corner of the property at a point coinciding with lands to the west at Number 3 South Avenue measuring easterly along the northern boundary bordered by lands known as Lot 1 (Volume 1218 Folio 760) a distance of fifty-six metres and eighty-eight hundredths of a metre to Arthur Wint Drive, then southerly along Arthur Wint Drive thirty-four metres and thirty hundredths of a metre, thence bordered to the south by Number 2 South Avenue measuring westerly along the southern boundary sixty-one metres and fifty-eight hundredths of a metre, thence northerly along South Avenue measuring twelve metres and thirty-eight hundredths of a metre, thence in a north-easterly direction bounded to the west by Number 3 South Avenue measuring forty metres and sixteen hundredths of a metre to the starting point.
 - 4. The Special Economic Zone to be referred to as Wheelersfield Development Limited.
- 5. The Special Economic Zone Authority to enter into a Licence Agreement not to exceed December 31, 2039 with Wheelersfield Development Limited.
