THE SPECIAL ECONOMIC ZONES ACT

**THE SPECIAL ECONOMIC ZONES (DESIGNATION OF BLUE EMERALD
SPECIAL ECONOMIC ZONE) ORDER, 2022**

In exercise of the powers conferred upon the Minister by sections 18(1) and 22 of the Special Economic Zones Act, 2016, and every other power hereunto enabling, the following Order is hereby made:—

1. This Order may be cited as the Special Economic Zones (Designation of Blue Emerald Special Economic Zone) Order, 2022.
2. On the recommendation of the Special Economic Zone Authority and after consultation with the Minister responsible for finance, the geographical area described in the Schedule shall be designated as a Special Economic Zone and shall be referred to as the Blue Emerald Special Economic Zone.
3. Entry by the Special Economic Zone Authority into a licence-agreement with Blue Emerald Limited is approved.

SCHEDULE

(Paragraph 2)

Blue Emerald Special Economic Zone

Description of Geographical Area

The geographical area designated as the Blue Emerald Special Economic Zone is described as follows—

All that parcel of land parts of Bog and Gibbons Estates in the parish of Clarendon (Plan bearing Survey Department Examination Number PE: 250943) containing by survey twenty-nine thousand eight hundred and ninety-five point eight seven six square metres and in the possession of SCJ Holdings Limited and registered at Volume 1424 Folio 22 of the Register Book of Titles, butting northerly on lands in the possession of SCJ Holdings Limited and registered at Volume 591 Folio 43 of the Register Book of Titles, butting easterly on lands in the possession of Marjorie Fray *et al* and registered at Volume 1207 Folio 43 of the Register Book of Titles, lands in the possession of Marjorie Fray *et al* and registered at Volume 1207 Folio 40 of the Register Book of Titles, lands in the possession of Catherine Edwards and registered at Volume 1086 Folio 495 of the Register Book of Titles, lands in the possession of Suzette Cooke and registered at Volume 1148 Folio 496 of the Register Book of Titles, lands in the possession of Bernard Morgan and registered at Volume 1273 Folio 553 of the Register Book of Titles, main road leading from Dawkins to Hayes, butting southerly on lands in the possession of SCJ Holdings Limited and registered at Volume 1424 Folio 22 of the Register Book of Titles, butting westerly on lands in the possession of SCJ Holdings Limited and registered at Volume 1424 Folio 22 of the Register Book of Titles.
