THE SPECIAL ECONOMIC ZONES ACT

THE SPECIAL ECONOMIC ZONES (DESIGNATION OF PAISLEY DEVELOPMENT
COMPANY SPECIAL ECONOMIC ZONE) ORDER, 2022

In exercise of the powers conferred upon the Minister by sections 18(1) and 22 of the Special Economic Zones Act, 2016, and every other power hereunto enabling, the following Order is hereby made:—

1. This Order may be cited as the Special Economic Zones (Designation of Paisley Development Company Special Economic Zone) Order, 2022.
2. On the recommendation of the Special Economic Zone Authority and after consultation with the Minister responsible for finance, the geographical area described in the Schedule shall be designated as a Special Economic Zone and shall be referred to as the Paisley Development Company Special Economic Zone.
3. Entry by the Special Economic Zone Authority into a licence-agreement with Paisley Development Company Limited is approved.

Paisley Development Company Special Economic Zone

Description of Geographical Area

The geographical area designated as the Paisley Development Company Special Economic Zone is described as follows—

Property : No. 26 Paisley Avenue, Part of Paisley Pen

Parish : Clarendon, Jamaica W.I.

1. LOCATION : The property is located approximately 2.8 km east of the parish capital of May Pen, Clarendon, and is comprised in the Certificate of Title registered at Volume 526 Folio 57 of the Register Book of Titles containing by survey 4.32 acres [save and except for the portion removed registered at Volume 1317 Folio 459 of the Register Book of Titles].

2. COORDINATES : Grid Reference - Jamaica Datum (JAD) 2001 At the north-eastern boundary corner:

Northings 645207.806;

Eastings 726468.126

At the south-western boundary corner:

Northings 644967.760;

Eastings 726313.396

3. ADJOINING PROPERTIES : The property is butted and bounded by the following properties:

North-easterly: On the main road known as Paisley Avenue from May Pen to Old Harbour.

South-easterly: On lands registered at Volume 1317 Folio 459 of the Register Book of Titles in the name of Factories Corporation of Jamaica Limited.

South-westerly: On lands in the possession of the Jamaica Railway
