THE STANDARDS (DECLARATION OF STANDARD SPECIFICATION)
(JS 360: 2022 JAMAICAN STANDARD SPECIFICATION FOR PROCESSED
FOODS — KETCHUP [REVISED]) NOTICE, 2022

In exercise of the power conferred upon the Bureau of Standards Jamaica by section 7 of the Standards Act, the following Notice is hereby given:—

1. This Notice may be cited as the Standards (Declaration of Standard Specification) (JS 360: 2022 Jamaican Standard Specification for Processed foods — Ketchup [Revised]) Notice, 2022.
2. The Specification for Processed foods — Ketchup which was formulated by the Bureau of Standards Jamaica under subsection (1) of section 7 of the Act is hereby declared to be a Standard Specification.

3. The Standards (Declaration of Standard Specification) (Processed foods — Ketchup) Notice, 1988, is hereby revoked.

4. Copies of the Standard Specification may be obtained from the Bureau of Standards Jamaica whose address is 6 Winchester Road, P.O. Box 113, Kingston 10.

THE COMPULSORY STANDARDS (DECLARATION OF STANDARD SPECIFICATION)
(JS 360: 2022 JAMAICAN STANDARD SPECIFICATION FOR PROCESSED
FOODS — KETCHUP [REVISED]) ORDER, 2022

In exercise of the power conferred upon the Minister by section 7 of the Standards Act, the following Order is hereby made:—

1. This Order may be cited as the Compulsory Standards (Declaration of Standard Specification) (JS 360: 2022 Jamaican Standard Specification for Processed foods — Ketchup) [Revised] Order, 2022 and shall come into force on the 28th day of April, 2023.

2. The Specification which was declared by the Standard (Declaration of Standard Specification) (Processed foods — Ketchup [Revised]) Notice, 2022 to be a Standard Specification, is hereby declared to be a compulsory Standard Specification.

3. The Compulsory Standards (Declaration of Standard Specification) (Processed foods — Ketchup) Order, 1988 is hereby revoked.
