#### THE TAX COLLECTION ACT

THE TAX COLLECTION (APPROVED WRITE-OFF) (NO. 7) ORDER, 2019

In exercise of the powers conferred on the Minister by section 47A(4) of the *Tax Collection Act* (hereinafter referred to as the "Act"), and of every other power hereunto enabling, the following Order is hereby made:—

- 1. This Order may be cited as the Tax Collection (Approved Write-Off) (No. 7) Order, 2019.
  - 2. Subject to section 47A(5) of the Act, I, as Minister, declare that—
    - (a) there is uncollected the sum of \$297,099,685.03 in tax arrears in respect of taxpayers, whose names and respective amounts are listed in the Schedule attached hereto;
    - the Commissioner General has determined that the sum specified in sub-paragraph
      (a), is uncollectible; and
    - (c) the sum specified in subparagraph (a), as it relates to the taxpayers listed in the attached Schedule, is written-off.
